Swartland Municipality awaits quotations from suitably experienced service providers for the Removal of Existing Floor Tiles and lay of New Ceramic Tiles (including Skirting) (Total area approximately 224.97m²) at Dieprivier Sportsgrounds, Malmesbury as per the specifications of the Civil Engineering Department, as stated in the official bid documentation.
