BELANGRIKE KENNISGEWING –
VERMINDERING VAN SPOEDBOETES

Die Verkeersafdeling van die Swartland Munisipaliteit gee hiermee kennis, na oorlegpleging met die betrokke howe en as deel van die veldtog om padveiligheid in die streek tydens die Desember 2011 vakansietyd te bevorder, dat oortreders alle spoedboetes (uitgesluit lasbriewe vir arrestasie) wat in die Swartland Munisipaliteit se jurisdiksie area opgelê is, tot en met 31 Januarie 2012 teen 50% vermindering kan aflos. Hierdie is 'n eenmalige vergunning met die samewerking van die Departement van Justisie en na die vermelde vervaldatum sal oortreders met die volle mag van die wet vervolgt word, met die oog op die implementering van die AARTO wets-regime in die nabye toekoms.

IMPORTANT NOTICE – REDUCTION OF
SPEED FINES

The Swartland Municipality Traffic Division hereby gives notice, after consultation with the related courts and as part of its campaign to promote road safety in the region during the December 2011 festive season, that offenders may redeem all their traffic speed fines (excluding warrants of arrest) accrued in the Swartland Municipal area of jurisdiction against a 50% reduction in the fines values until and on 31 January 2012. This is a once-off concession in conjunction with the Department of Justice and after the stated expiry date, offenders will be prosecuted with the full force of the law, having regard to the implementation of the new AARTO regime in the near future.
