Swartland Municipality awaits quotations from suitably experienced service providers for the Reparation of Vibracrete Wall at Gene Louw Sportsgrounds Moorreesburg as per the specifications stated in the official bid documentation.

Tenderers must be registered with the CIDB in a 1SQ Class of construction works. Proof of registration (Registration number) must be included in the tender documents.

The contract is classified as a small contract and the 80/20-preference point system will be used for the evaluation of the contract. For bidders to qualify for the advantages of the B-BBEE Act, they must thoroughly complete the attached Annexure MBD 6.1. **There will be no benefits if the schedule is not thoroughly completed.** Bidders are required to submit **original and valid B-BBEE Status Level Verification Certificates or certified copies** thereof together with their bids, to substantiate their B-BBEE rating claims.
