AMENDMENT OF THE SWARTLAND MUNICIPAL SOCIAL DEVELOPMENT POLICY AND STRATEGY 2013 WYSIGING/HERSIENING VAN DIE SWARTLAND MUNISIPALE SOSIALE ONTWIKKELINGSBELEID EN STRATEGIE 2013

Swartland Municipality is currently in the process of compiling the amendment of the Swartland Municipal Social Development Policy and Strategy 2013 that was approved by Council. The Municipal Systems Act, 32 of 2000, refers to the role and responsibilities of the municipality. Emerging from the Swartland Social Development Policy and Strategy 2013, the municipality works according to the following focus areas:

Swartland Munisipaliteit is tans in die proses om die Swartland Munisipale Sosiale Ontwikkelingsbeleid en Strategie van 2013 soos deur die Raad goedgekeur te wysig/hersien. Die Munisipale Stelsels Wet, 32 van 2000, verwys na die rol en verantwoordelikheid van die munisipaliteit. 1. *Establish child care facilities and promote child development / Vestiging van kindersfasiliteite en die bevordering van vroeë kinderontwikkeling*
2. *Promote Youth development / Bevordering van Jeugontwikkeling*
3. *Promote collaboration and co-ordination / Bevordering van samewerking en koördinerings*
4. *Promote access to the economy / Bevordering van toegang tot die ekonomie*
5. *Lobbying for the Vulnerable / Voorspraak vir weerlose persone*
