### TENDER L05/23/24: SALE OF ERF 2652 RIEBEEK KASTEEL

Tenders are hereby invited from Riebeek Kasteel based denominations/congregations for the purchase of Erf 2652 Riebeek Kasteel, situated in Rondeberg Crescent, Riebeek Kasteel.

Erf 2652 Riebeek Kasteel is ± 557 m<sup>2</sup> in extent, is undeveloped land and is zoned as Community Zone 2, which allows the erection of a place of worship as primary use. The objective of Community Zone 2 is to provide for places where communities can congregate and worship according to the custom of their specific faith or religion.

A two-envelopes system will be used for evaluating this tender, as set out in the tender document. Both envelopes, properly sealed and marked respectively as indicated below, must be deposited into the tender box at the municipal offices in Kerk Street, Malmesbury by not later than **12:00 on Friday, 5 July 2024**, after which the tenders marked "Envelope 1" will be opened and made public at the municipal offices on the same day. Tenders marked "Envelope 2" will be opened in public at the Municipal Offices aforementioned on a date and at a time of which all tenderers will be advised by the Municipality but in any event before expiry of 90 days from the closing date of the tenders.

**Envelopes must be marked as follows:**

- "ENVELOPE 1: DEVELOPMENT PROPOSAL: ERF 2652 RIEBEEK KASTEEL"
- "ENVELOPE 2: MONETARY OFFER: ERF 2652 RIEBEEK KASTEEL"

**Very important: Both envelopes must also indicate the name, in print, of the tenderer. The Municipality reserves the right not to open any envelope not identified as indicated above, and to disqualify the tenderer who did not meet this requirement.**

**Bidders must complete the attached Annexure MBD 6.1. Preference points MUST be claimed in paragraph 6.1. Bidders are required to submit Proof of Locality in order to claim points for locality.**

Late, telegraphed, telephoned, telexed, telefaxed or e-mailed tenders will not be considered and the Municipality does not bind itself to accept the highest, part of or any tender.
