### CONSTRUCTION OF THE NEW CELL 3A AT THE HIGHLANDS LANDFILL SITE: CIVIL AND LINING WORKS

Tenders are hereby invited for the **CONSTRUCTION OF THE NEW CELL 3A AT THE HIGHLANDS LANDFILL SITE: CIVIL AND LINING WORKS**.

The physical address for collection of tender documents is: Offices of the Director: Civil Engineering Services, Swartland Municipality, Piet Retief Street (PEP building), Malmesbury. Documents may be collected during working hours after 09:00 from **Monday, 9 September 2024**. A non-refundable tender fee of **R490-00**, payable in cash, credit/debit card or Electronic Funds Transfer (EFT) is required on collection of the tender documents. Payment needs to be completed at the cashiers' desk (c/o Kerk & Hill Street) and proof of payment needs to be provided to the Civil Engineering Services office in Piet Retief Street to obtain the document. Tenders may only be submitted on the prescribed tender documents.

Tenderers must be registered with the CIDB in a **CE** class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading designation of **7CE or higher**.

Completed and sealed tenders, appropriately marked with "**TENDER T13.24.25: CONSTRUCTION OF THE NEW CELL 3A AT THE HIGHLANDS LANDFILL SITE: CIVIL AND LINING WORKS**" must be deposited in the tender box at the Municipal Head Offices of the Swartland Municipality, on the corner of Kerk and Voortrekker Street, Malmesbury, before **12h00, Friday, 11 October 2024** after which tenders will be opened.

A **compulsory** clarification meeting with representatives of the Employer and the Engineer will take place on **Wednesday, 18 September 2024 at 11h00 (Registration closes at 11:05)**. Prospective tenderers will meet at the Banqueting Hall, Municipal offices, Kerk Street, Malmesbury, after which a compulsory site visit to the Highlands landfill will take place before the meeting is considered over.

Bids will be evaluated in accordance with the Council's Preferential Procurement Policy (available on their website) and the attached specifications. The 80/20-preference point system will be used for the evaluation of the contract. **Preference points will not be allocated if Annexure MBD 6.1, included in the tender documents, is not completed. Preference points MUST also be claimed in paragraph 6.1.** Bidders are required to submit **original and valid B-BBEE Status Level Verification Certificates or certified copies** thereof together with their bids, to substantiate their B-BBEE rating claims. Bidders are also required to submit Proof of Locality in order to claim points for locality.

Electronic/ Faxed tenders will not be accepted; incomplete tenders and tenders received late will not be considered. The Council does not bind itself to accept the lowest or any tender. Tenders shall be valid for a period of 90 days from the tender closing date.
