CLOSURE OF ALLEY IN DARLING FOR PUBLIC USAGE

Notice is hereby given that the Municipality intends to close off the alley between erven 622, 679 and 2058 Darling (located between Fontein and Delphinium Streets) for public usage by erecting gates on both sides of said alley.

The alley was initially created solely for protecting the sewage pipe-line servitude located therein, and not as public thoroughfare, although the practice has evolved over the years to also use it as such.
