**PROPOSED OUT-OF-HAND ALIENATION OF A PORTION OF FOURTH
AVENUE, MOORREESBURG**

Notice is hereby given in terms of the Council's By-law and Policy relating to the Transfer of Municipal Capital Assets that the Council has granted approval for a portion of Fourth Avenue, Moorreesburg, situated between Groeneweide and Constantia Streets, to be alienated and transferred out-of-hand to Hoerikwaggo CC, for consolidation with Erf 2282, Moorreesburg.

The property concerned is vacant, 1693 m² in extent, and is regarded a 'non-viable asset' in that it cannot be developed on its own for residential purposes or function as a separate entity. The purchaser wants to incorporate it into Erf 2282 for future development of the consolidated property.

In addition to the purchase price of R88 036,00 (VAT excluded) the purchaser shall also be responsible for all costs ancillary and incidental to this transaction, including advertisement costs, transfer costs as well as the costs of consolidation.

**VOORGENOME UIT-DIE-HAND-VERVREEMDING VAN GEDEEELTE VAN VIERDE LAAN,
MOORREESBURG**

Kennis geskied hiermee in terme van die Raad se Verordening en Beleid insake die Oordrag van Munisipale Kapitale Bates dat die Raad goedkeuring verleen het dat 'n gedeelte van Vierde Laan, Moorreesburg, geleë tussen Groeneweide- en Constantiastraat, uit-die-hand-uit vervreem en oorgedra mag word aan Hoerikwaggo CC, vir konsolidasie met Erf 2282, Moorreesburg.

Die betrokke eiendom is 1693m² groot en word beskou as 'n 'nie-bestaanbare bate' deurdat dit nie op sigself vir residensiële doeleindes ontwikkel of as afsonderlike entiteit kan funksioneer nie.
