- Yzerfontein hawe Erwe 560/9 & 560/35 (munisipale eiendom): Strukture sluit in 'n kroeg, mediese tent, verhoog, markiestent en omheining.
- Yzerfontein hawe Erf 562: Van die strukture (toilette, heining, toegangsbeheer) is geleë op hierdie eiendom van die Departement Openbare Werke.
- Yzerfontein vismark vir die "oorvloei" van parkering. Ander parkeerareas wat aangedui word vir gebruik, is o.a publieke parkering by die hoofstrand, Schaapeiland, Ocean Village sentrum en die kerk.

- *Yzerfontein fish market for the "overflow" of parking. Other parking areas indicated for use include public parking at the main beach, Schaapeiland, Ocean Village center and the church.*
