BY-ELECTION OF WARD 7: NOMINATIONS OF CANDIDATES

BACKGROUND

Ward committees serve as an important mechanism to encourage and extend participative democracy in local government matters. A ward committee consists of the ward councillor, who is – *ipso facto* – the chairperson of the committee and ten other persons.

Paragraph 5(2) of the Rules and Procedures for Ward Committees determines that members of the ward committees be elected by virtue of geographical representation.

Paragraph 10(3) of the Rules and Procedures for Ward Committees determines further that, should a vacancy arise for the position of ward committee member during the term of a ward committee, such vacancy must be filled as soon as possible after it has been reported, by way of a by-election.

Paragraaf 10(3) van die Reëls en Prosedures vir Wykskomitees bepaal verder dat, ingeval 'n vakature in die amp van wykskomiteelid gedurende die termyn van 'n wykskomitee ontstaan, moet die vakature so spoedig moontlik na die rapportering daarvan by wyse van 'n tussenverkiesing gevul word.
