**AMENDMENT OF CONDITIONS OF APPROVAL: REZONING AND CONSENT USE ON THE FARM GROOTWATER, NO. 1198, DIVISION MALMESBURY**

Your application, with reference number MAL/14822/NJdK, dated 23 September 2025, on behalf of the Meerkat Development Community, refers.

By virtue of the authority delegated to the Senior Manager: Development Management in terms of Council Decision No. 4.1 dated 28 March 2019, as determined by Section 79(1) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), the application for the amendment of conditions of approval regarding the rezoning and consent use on the farm Grootwater, no. 1198, Division Malmesbury, is approved in terms of Section 70 of the By-Law, as follows:

**1. TOWN PLANNING AND BUILDING CONTROL**

- a) Condition B1.d), contained in approval letter 15/3/3-15/Farm\_1198, dated 8 March 2017, as amended on 30 November 2022, amended on 16 February 2023 and amended 12 May 2023 to read:

*...B1.d) A footprint area for holiday accommodation 3,6560ha is granted to allow for the 'bush village camp', 'bush camp' and 'bush house' which will be used for guest accommodation (See plan number 2127-02-100, Rev: LA2)..."*

be amended to read as follows:

*"...B1.d) A footprint area for holiday accommodation 3,6560ha is granted to allow for the 'bush village camp', 'bush camp' and 'bush house' and a manager's cottage (staff house) and the check-in/reception kiosk' which will be used to manage guest accommodated (See plan number 2127-02-100, Rev: LA3)..."*

**2. GENERAL**

- a) All other conditions of approval contained in approval letter 15/3/3-15/Farm\_1198, dated 8 March 2017 remain applicable;
- b) The approval is, in terms of section 76(2)(w) of the By-Law, valid for 5 years. All conditions of approval be complied with. Once all the conditions of approval have been met, the land use will be permanent and the approval period will not be applicable anymore.
