PROPOSED REZONING OF PORTION 3 OF FARM ROZENBURG NO 771, DIVISION MALMESBURY

Your application, with reference MAL/12139/ZN/MV, dated 27 October 2021, on behalf of JR Trust, regarding the subject refers.

By virtue of the authority delegated to the Senior Manager: Built Environment in terms of Council Decision No. 4.1 dated 28 March 2019, as determined by Section 79(1) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), the application for the rezoning of portion 3 of farm Rozenburg no 771, Division Malmesbury, is approved in terms of Section 70 of the By-Law, subject to the condition that:

1. TOWN PLANNING AND BUILDING CONTROL

- A portion (218m² in extent) of portion 3 of farm Rozenburg no 771, Division Malmesburuy be rezoned from Transport zone 1 to Industrial zone 3 in order to accommodate a risk activity (diesel depot) as presented in the application;
- b) Building plans be submitted to the Senior Manager: Build Environment for consideration and approval;
- Application be made for the erection of advertising signs at the Senior Manager: Build Environment for consideration and approval;
- d) The fuel pump at the diesel depot be restricted to be used only by the transport business on the property and are not available to the public;
- Access to the diesel depot complies with the requirements of Chapter 13.1.3 of the Swartland Planning By-law;

2. GENERAL

- a) The approval does not exempt the owner/developer of adherence to any other legal procedures, applications and/or approvals related to the intended land use;
- b) The approval is, in terms of section 76(2)(w) of the By-Law, valid for 5 years. All conditions of approval be implemented before diesel depot comes into operation, without which, the approval will lapse.
