PROPOSED OCCASIONAL USE OF LAND ON PORTION 3 OF THE FARM GOEDGEDACHT 1028, DIVISION MALMESBURY

Your application received on 15 September 2021 on behalf of sf HAMMAN Trust, regarding the subject refers.

By virtue of the authority delegated to the Senior Manager: Built Environment in terms of Council Decision No. 4.1 dated 28 March 2019, as determined by section 79(1) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), the application for an occasional use of land on portion 3 of the farm Goedgedacht no. 1028, Division Malmesbury is hereby approved in terms of section 70 of the By-Law, subject to the following conditions that:

1. Town Planning and Building Control

- (a) The occasional use of land permits the hosting of a music event, Into the Wild on a portion of the farm for a maximum of 500 patrons;
- (b) The occasional use of land is only valid for 6 November 2021 from 12h00 until 22h00;
- (c) The music therefore be turned off at 22h00 and that the patrons vacate the premises;
- (d) All structures to be used for the music event must be erected by a professional person to avoid any injuries that may occur during the event and setting up/breaking down of the tents:
- (e) The event organizer (Troy Evason) at all times give effect to the safety and security plan for the event as submitted with the application;

2. Cleaning services

- (a) There is not a solid waste removal service available to the event.
- (b) There is sufficient capacity at the Highlands Landfill to receive waste of a general and household nature. Provided it is transported to the facility on private initiative and undertaking. Waste accepted at the landfill is subject to the regulations pertaining types of waste allowed on the landfill as well as relevant fees payable

3. Sewerage

(a) That sewer services can only be provided by means of a vacuum tanker. In order to utilise this service, sufficient on site storage must be provided.

4. Water

- (a) That no Municipal drinking water can be supplied for the proposed Festival.
- (b) That water supplied for drinking complies to SANS 241.

5. General

(a) The approval does not exempt the applicant from adherence to any and all other legal procedures, applications and/or approvals related to the intended land use, as required by provincial, state, parastatal and other statutory bodies.
