# PROPOSED TEMPORARY DEPARTURE ON PORTION 3 OF THE FARM GOEDGEDACHT 1028, DIVISION MALMESBURY

Your application received on 21 February 2023 on behalf of SF HAMMAN Trust, regarding the subject refers.

By virtue of the authority delegated to the Senior Manager: Development Management in terms of Council Decision No. 4.1 dated 28 March 2019, as determined by section 79(1) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), the application for a temporary departure on portion 3 of the farm Goedgedacht no. 1028, Division Malmesbury is hereby approved in terms of section 70 of the By-Law, subject to the following conditions that:

#### 1. **Town Planning and Building Control**

- The temporary departure of the land permits the hosting of a music event, Into the Wild on a (a) portion (8000m² in extent) of the farm for a maximum of 800 patrons;
- The temporary departure of the land is only valid for setup from 29 to 21 March 2023, hosting the (b) event on 1 April 2023, and strike on 2 April 2023;
- The music therefore be turned off at 01h00 on Sunday 2 April 2023 and that the patrons vacate (c) the premises:
- All structures to be used for the music event must be erected by a professional person to avoid (d) any injuries that may occur during the event and setting up/breaking down of the tents;
- The event organizer (Troy Evason) at all times give effect to the safety and security plan for the (e) event as submitted with the application;

#### 2. **Cleaning services**

- No solid waste removal service be available to the event. (a)
- Sufficient capacity exist at the Highlands Landfill to receive waste of a general and household (b) nature. Provided it is transported to the facility on private initiative and undertaking. Waste accepted at the landfill is subject to the regulations pertaining types of waste allowed on the landfill as well as relevant fees payable

(a) Sewer services can only be provided by means of a vacuum tanker. In order to utilise this service, sufficient on site storage be provided.

- (b) Water supplied for drinking complies to SANS 241

## 5. General

(a) The approval does not exempt the applicant from adherence to any and all other legal procedures, applications and/or approvals related to the intended land use, as required by provincial, state, parastatal and other statutory bodies.
