# PROPOSED CONSENT USE ON PORTION 1 OF FARM DROOGE VALLEY NO 456, DIVISION MALMESBURY

Your application, with reference number 297~1-456-SWM, dated 20 September 2022, on behalf of the Basie Basson Trust, refers.

By virtue of the authority delegated to the Senior Manager: Development Management in terms of Council Decision No. 4.1 dated 28 March 2019, as determined by Section 79(1) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), the application for a consent use on portion 1 of farm Drooge Valley no 456, Division Malmesbury, is approved in terms of section 70 of the By-Law, subject to the conditions that:

## 1. TOWN PLANNING AND BUILDING CONTROL

- a) The total footprint of the sand and gravel mining activity may not exceed 252,5923ha, as presented in the application;
- b) The mining activity is limited to the extraction of sand and gravel, as presented in the application;
- c) Drinking water be accessible and available on site, consistent with the SABS 241-1984 standards, to the satisfaction of the Director: Civil Services;
- d) No vehicles may be serviced on site;
- e) All oil / diesel spills be cleaned up using the necessary precautions and procedures, as required by the Environmental Management Plan;
- f) The health requirements as set from time to time by Department of Health, be met;
- g) Should any human remains be found during the mining process, SAHRA and Heritage Western Cape must be notified immediately;
- h) Mining activities be conducted in accordance with the approved Environmental Management Programme and layout plan;
- Dust on haul roads meet the requirements of the National Environmental Management Air Quality Act, 2004;
- j) The Environmental Authorisation holder ensures that vegetation be removed only in the specific area that is to be worked, in phases, to prevent soil erosion;
- k) Topsoil be stripped, stockpiled and re-spread in accordance with the Environmental Authorisation:
- Stockpiling of topsoil be restricted to alternate phases on the development site and no off-site stockpiling will be permitted beyond the boundaries of the approved 252,5923ha site;
- m) Management of topsoil be conducted in accordance with the approved EMP and the EA;
- n) Drainage be provided on mining sites after mining, to the satisfaction of the EA;

- o) The waste storage facility for harmful substances shall be structured according to the NEMA, 2008, (Act 62 of 2008);
- p) No vehicle or pedestrian access into natural areas beyond the demarcated boundary of the site will be permitted;
- q) Visible, semi-permanent markers be placed along boundaries of the approved mining area, prior to mining activities commencing;
- r) Rehabilitation of each phase be completed in accordance with the EMP and to the satisfaction of the Department of Mineral Resources;
- s) Dust suppressions measures be implemented during mining activities and this may include spraying the mining area and access road with water and/or an environmentally friendly dust allying agent, in accordance with the EMP;
- t) A social contribution agreement be entered into between the mine owner and the Municipality to be executed and finalised within the duration period of the mining activities;

## 2. WATER

- a) No municipal drinking water can be provided:
- b) No pollution of surface water or groundwater resources may occur due to the mining activities on the property;
- c) The person who owns, controls, occupies or uses the land in question employs preventative measures of water pollution, to the satisfaction of the Department: Water and Sanitation;

## 3. SEWERAGE

- a) Sewerage services can only be provided for household sewerage by means of a vacuum truck;
- b) Sufficient and acceptable toilets be provided on site;

### 4. GENERAL

- a) The applicant/developer complies with the conditions of the Environmental Authorisation of the Department of Mineral Resources and Energy, reference number WC30/5/1/2/2/10157MR, dated 12 August 2022;
- b) The conditions of the Department of Transport and Public Works, reference TPW/CFS/RP/LUD/REZ/SUB-26/270 (Job 21115), dated 23 February 2023 be complied with.
- c) The approval does not exempt the applicant from adherence to any other legal procedures, applications and/or approvals related to the intended land use, as required by provincial, state, parastatal and other statutory bodies;
- d) The approval is only valid for the same period as the mining rights, once the mining permit has been received.
