The Municipal Manager stated that 54.9% of the capital budget has been spent. The target was for the expenditure to be at least 35% by the end of December, but the directors gave the assurance that the total capital expenditure for the 2021/2022 financial year would be $\pm 95\%$.

Furthermore, the Municipal Manager stated that the target regarding number of jobs created by the Municipality's capital projects (contracts> R200 000) for the 2021/2022 financial year is a total of 150 jobs. If the perennial tenders are taken into account, the total will increase by 66 jobs.

The Municipal Manager stated that the small capital projects are completed in terms of the supply chain management process. The notebooks for the rest of the board members will be delivered within the next three to eight weeks.




Malmesbury WWTW Effluent 2020 - 2022






Moorreesburg WWTW Effluent 2020 - 2022











Voëlvlei Dam Storage 2020 - 2022


























GRAPH 9 RECYCLING AND USED AIRSPACE VOLUMES MARCH 2022





VERSLAG: SWARTLAND RIOOLWERKE (MAART 2022)

REPORT: SWARTLAND WASTE WATER TREATMENT WORKS (MARCH 2022)

OPERATION OF ACTIVATED SLUDGE TREATMENT WORKS

Below is comments from the consulting chemists with regards to operational matters of the various waste water treatment works.

MALMESBURY (139%)

- 1. An average daily flow of 5 613m³/d was recorded in February (56.1% capacity).
- 2. An organic load of 13 875 kg COD/d was imposed on the plant, exceeding the organic design capacity (139% capacity).
- 3. Pant performance was nonetheless satisfactory at both aeration tanks.
- 4. Nitrification of ammonia nitrogen was virtually complete and removal of organics was satisfactory. Air bubble blower No.2 unserviceable, due to loadshedding. Sent for repairs.
- 5. The mixed liquor pH's were satisfactory at 7.15/7.28, respectively.
- The final effluent complied with the chemical limits of the General Limit, relevant to parameters measured.
- 7. Disinfection was virtually complete (1 Faecal Coliform per 100 ml).

MOORREESBURG (70%)

- 1. Unable to carry out inspection as plant operation stopped due to construction. Plant extensions in progress.
- 2. Only the final effluent sampled.
- 3. The final effluent exceeded the chemical limits of the General Limit relative to conductivity, ammonia nitrogen, total suspended solids, ortho phosphate and chemical oxygen demand. Conductivity is a function of the influent, however.
- 4. Chlorine residual were very low. Increase chlorination and maintain 0.25 mg/l free chlorine. Dosing HTH tablets daily by hand.
- 5. Disinfection was poor. This was due to low chlorine residuals as well as substantial solids in the effluent.

DARLING (149%)

- 1. An average daily flow of 1 193 m³/d was recorded in February.
- 2. An organic load of 2 335 kg COD/d was imposed on the plant, exceeding the organic design capacity (149% capacity).
- Plant performance remained poor in the aeration basin relative to the nitrification of ammonia nitrogen, due to under-aeration and the sludge mass being wholly excessive. Removal of organics was nonetheless satisfactory.
- 4. Maintain 600-700 ml/l solids in the aeration basin, by increasing sludge wastage.
- 5. The ST effluent was of poor chemical quality with periodic sludge losses occurring. The underflow sludge return rate was ideal. There is a noticeable improvement in the condition of the ST, however.

- 6. FE1 exceeded the chemical limits of the General Limit relative to the marginally high conductivity, ammonia nitrogen, free chlorine and chemical oxygen demand. The latter complied after filtration, however. FE2 (reed bed) complied with the chemical limits of the Irrigation Limit up to 500 m³, relevant to parameters measured.
- 7. The chlorine residuals were slightly high at FE1. Reduce chlorination and maintain 0.25 mg/l free chlorine.
- 8. Disinfection was adequate at FE1 (6 Faecal Coliforms per 100 ml). Disinfection was satisfactory at FE2 (980 Faecal Coliforms per 100 ml).

RIEBEEK VALLEI (51%)

- 1. An average daily flow of 709 m³/d was recorded in February (47.3% capacity).
- 2. An organic load of 763 kg COD/d was imposed on the plant (50.9% capacity).
- 3. The sludge mass was slightly high. Maintain 200 300 ml/l measured), by increasing sludge wastage.
- 4. Plant performance was satisfactory in the aeration basin relative to the nitrification of ammonia nitrogen, which was extensive. Removal of organics was inhibited, however, possibly due to power failures prior to sampling.
- 5. Phase separation was complete across the clarifiers, but ST2's effluent was of relatively poor chemical quality with periodic sludge losses occurring.
- 6. The underflow sludge return rates were adequate.
- 7. No chlorine gas stock. Using HTH tablets. The chlorine residuals were satisfactory. Disinfection was poor, however possibly due to solids in the chlorine contact tank. Said tank should be cleaned at regular intervals.
- 8. The final effluent complied with the chemical limits of the General Limit, relevant to parameters measured.

EXECUTIVE SUMMARY: COMMUNITY DEVELOPMENT

Introduction

As part of the Development Service Department: Community Development division strategic Key Performance Indicators (KPI's) were established as part the performance management system. The Community Development Division is reporting monthly on the Key Performance Indicators.

There is a link between the KPI's, IDP and the Swartland Municipal Social Development Policy and Strategy, which has six strategic focus areas. For reporting to the Portfolio Committee, feedback will be given in terms of the Key Performance Indicators as follows:

Key Performance Area: Community Development:

FOCUS AREA – EARLY CHILDHOOD DEVELOPMENT:

Legislation applicable: Children's Act of 2005, Constitution Schedule 4B and 5B

Ph-09-0114: Promote the development of child facilities

Key Performance Indicators (KPI's):

- 1. Number of capacity building sessions with ECD organisation in the Swartland municipal area:
- We have a target of 10 capacity-building sessions with ECD organisation for the year. For the month of March 2022, one capacity-building sessions was held. Swartland ECD Forum Capacity Building Engagement (12 March 2022) where 94 ECD teachers/principles attended. Our target for the year is to have of 10 capacity building sessions with ECD organisations.
- 2. Number of Quarterly reports on the implementation of capacity building intervention sessions submitted to the director:
- Each quarter of the financial year reporting is done on the capacity building interventions in order to determine if the sessions had an impact on the ECD organisations.

Quarterly report on capacity building interventions implemented from January- March 2022 by Swartland Municipality, Department Community Development in partnership with various stakeholders. **JANUARY 2022**

1) NPO INFORMATION SESSION- MALMESBURY MAJORETTES- 8 JANUARY 2022

The Swartland Municipality, Community Development Department conducted a NPO Information session with the Malmesbury Majorettes committee to capacitate them on the following aspects:

- Understanding the relevancy of the NPO Registration
- The NPO Act No. 71 of 1997
- Finances (Financial Statements, Narrative Reports, Budgeting and Planning)
- Governance, Yearly Planning and Implementation

Based on the abovementioned aspects, the information that was provided was more than what they considered and requested that a follow up session to be planned. The group agreed to recruit additional members, as the existing amount of members are too few. The group agreed that a time-schedule, be compiled to determine the prioritization of activities and the relevancy of what is crucial which is time consuming needs urgent attention.

Way forward:

- Determine date for workshop on NPO registration and legalization of the Malmesbury Majorettes.
- o Identify critical matters; provide guidance during the workshop and pre-consider monitoring and evaluation session that will assist with the sustainability of the organization.
- o Determine short-term; medium-term and long-term implementation planning

2) SWARTLAND KINDERLAND AKADEMIE TRAINING SESSION- 29 JANUARY 2022

The Swartland Municipality, Department Community Development in partnership with Kinderland Akademie embarked on the role out of a Mathematical support programme within the ECD Sector of the Swartland.

ECD centers, Crèches, Afterschool care programmes and playgroups has been informed about this opportunity which will be beneficial not only to the facilities and practitioners but to the learners and parents. Fifty-three practitioners took on this opportunity and attended the first session, which has taken place at the Swartland Municipality Town Hall, Malmesbury.

The Kinderland Akademie Team has embarked on extending on funding to provide additional support services in terms of additional learning material and transport funds to the attendees.

The programme looked at the following guidelines:

- The facilities daily implementation programme and how to incorporate the mathematical programme as part of the daily routine.
- The outline of mathematical assessment + learning activities for the 3-5 year old age groups
- How to utilize the learning materials which has been provided

Way Forward:

- That the programme are streamlined, according to the government school terms, which means once per quarter a session will be implemented with the attendees.
- Additional support been considered and will be provided via WhatsApp, to help with understanding the lessons planning and what tools to use for implementation.
- An onsite-visit for assessment and support be scheduled, onsite monitoring and evaluation will be done to see what additional resources and assistance can be offered.

FEBRUARY 2022

1) <u>FOLLOW-UP NPO SESSION WITH DAM (DIGNITY FOR ABUSED MOTHERS ORGANIZATION-14 FEBRUARY 2022</u>

The Swartland Municipality, Department Community Development and the Supervisor of the Department of Social Development conducted a follow-up session with (DAM) Dignity for Abused Mothers. The session was done to ensure that the guidelines is followed and that collective interventions with various stakeholders are rendered. Therefore, the team looked at the following legislative administrative tasks that are outstanding and the revision of the objectives of the organization.

Objectives identified to streamline the process for implementation:

- Revision of Constitution and the objectives.
- Revision of Business plan
- Finances (Financial Statements, Narrative Report- Feedback and Budgeting)

Based on the highlighted aspects, the founder of DAM asked that she get time to assess the recommendations provided.

Way forward:

That the Founder of DAM provides feedback in the next two months if she wants to continue with the organization in order for support services be provided.

MARCH 2022

1) SWARTLAND ECD FORUM ENAGEMENT- 12 MARCH 2022

The Swartland Municipality in collaboration with various stakeholders such as Department of Social Development; Department of Education; West Coast College; Goedgedacht; Sinethemba and Grassroots Educare Centre conducted an engagement with all relevant ECD/ Afterschool Care facilities within the Swartland region. The engagement was implemented to provide content in terms of the shift

from the Department of Social Development to the Department of Education for the 0-5 year's age groups.

The session covered the following aspects such as:

- Goedgedacht- Sustaining vegetables gardens at ECD/ Afterschool Care facilities
- The shift from the Department of Social Development to the Department of Education
- The implementation phases of West Coast College Level Trainings
- Department of Social Development (Registration and Re-registrations; Funding cycles and Afterschool Care Support Services)

Way forward:

- o Provide feedback to all respective facilities in terms of the presentations presented and feedback provided by the Department of Education.
- That the Swartland ECD Forum Management Team, schedule the next training session for the next two quarters.

3. Number of unregistered facilities assisted to register their facilities:

- It is essential to assist unregistered facilities on a continuous basis to ensure they become legal. For the month of March 2022, two ECD facilities were assisted to register their facilities.

The ECD facilities that was assisted: Assistance with registration: Learn & Play Daycare Malmesbury (Upcoming ECD) and Sonneblomland Daycare Abbotsdale (Land application).

Job application forms: Swartland Municipality application form (35 people); Swartland Municipality Database EPWP forms (143 people); Z83 forms (48 people); WCDM (4 person); Career Guidance and Support (33 people); Opportunities (Training/Workshop/Vacancies) (82 people); Swartland Municipality Annual Career Exhibition on 9-10 March 2022: Wesbank Secondary School (578 learners); Ilingelethu Secondary School (255 learners); Swartlan Hight School (435 learners); Schoonspruit Senior Secondary School (902 learners); Samaai Construction Induction Programme on 15 March 2022 at Chatworth POP centre (15 youth)

On a monthly basis the youth office, also circulate job opportunities to relevant stakeholders, community, NGO's, government departments electronically via e-mail. Career guidance is also done at the Thusong centre where the youth office is based.

2. Number of youths from the Swartland community who entered into job opportunities with assistance from the Youth office

- The youth office link with government departments, the private sector, businesses and NGO's to assist youth of the Swartland to enter into job opportunities. For the month of March 2022, one youth started working at Elkana Child and Youth Care Cetnre as an assistant the the Afterare and one youth started as EPWP worker at Swartland Municipality working at the Stores and another youth sarted at StatsSA as fiel worker on a contract basis.

3. Number of training, internships and learnership opportunities in collaboration with other Departments with the assistance from the Youth Office:

For the month of March 2022, one youth entered into a job opportunity as a Teacher Assistant on a 1 year learnership at the Swartland Indoor Sport Centre and 1 enrolled at the Western Cape Government Year Beyond Programme.

In total 1577, people were reached at the Ilingelethu Thusong Centre.

2. Number of Thusong Mobile Outreaches implemented in the Swartland Municipal area:

- The Thusong Mobile outreaches is a mechanism to take services to the people with anchor departments such as (SASSA, Home Affairs, DSD; DOL). In the Swartland Municipal area, Thusong Mobile Outreaches is not subject to the anchor department, but we include NGO's, other government departments, and businesses to collectively render services to communities.

For the month of Marh 2022, no Thusong Mobile Outreaches was held. The next Thusong Mobile is planned for Moorreesburg on 17 May 2022.

The target for the year is to have 5 Thusong Mobile Outreaches.

3. Report to the Director Development Services on the number of referrals from the Community Development Division

- This KPI was developed in order to capture how many referrals are done to other departments where people need assistance. Follow-up is done to determine if people were helped. The following referrals was done for the month of March 2022: SM Youth Office to SEDA (3); SM Youth Office to the Development Department (1); Youth Office to DSD (1); Youth Office to WCED (1); Youth Office to Youth Office to DSD Office (1); Thusong Centre to Civil Department (1; Thusong Centre to Law Enforcement(1); Thusong Centre to SASSA (2). Total referrals was seven for the month.








ESTIMATED BUILDING VALUES

6.1 PROPOSED REZONING, DEPARTURE AND CONSENT USE ON ERF 278, KORINGBERG (15/3/3-7; 15/3/4-7; 15/3/10-7) (WARD 1)

The chairperson requested Ms de Jager, as author, to give the background on the application received for the rezoning, departure and consent use on Erf 278, Koringberg.

Ms de Jager stated that the property is adjacent to an activity corridor and the character of the area is primarily residential. The Spatial Development Framework (SDF) proposes limited business opportunities, mixed uses and the potential for flats along activity corridors.

The proposed application is therefore supported, except for the consent use for a bottle store. Some of the factors that were taken into consideration for the refusal of the bottle store as a consent use are the proximity to the school, the impact on the community and the public interest confirmed by the objections received.

RESOLUTION

- A. The application for the rezoning of Erf 278, Koringberg from Residential Zone 1 to Business Zone 2 be approved, in terms of Section 70 of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020);
- B. The application for a consent use on Erf 278, Koringberg be approved, in terms of Section 70 of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020);

- (a) Erf 278, Koringberg be rezoned from Residential Zone 1 to Business Zone 2: Neighbourhood Business, in order to accommodate:

 - (iii) 6 x flats (27,5 m² each);
- (b) The consent use be restricted to a place of assembly, as presented in the application:

- (e) Music be permitted in the place of assembly only during operating hours detailed in condition (d)(i) and (ii) and not be permitted on Sundays or closed days closed days are Good Friday and Christmas Day and that the volume of music be consistent with the requirements of the Western Cape Noise Regulations;
- (f) The use of amplifying sound equipment, speakers, megaphones or any such appliance, be strictly prohibited outside the place of assembly;
- (g) The Western Cape Noise Regulations be complied with at all times;
- (h) The playing of music outside of the place of assembly, in the parking lot or street, be prohibited;
- (i) No guests be allowed to remain at the place of assembly or in the parking lot on the site outside of operating hours;

- (r) A Certificate of Compliance be obtained from the West Coast District Municipality for the operation of the place of assembly;
- (s) A trade licence be obtained from Swartland Municipality for the operation of the shops;
- (t) No off-site parking be allowed;
- (u) Should the applicant fail to take effective steps to the satisfaction of the Senior Manager: Built Environment to ensure proper compliance with the conditions of approval, the approval for the consent use may be withdrawn after following due process;

(a) The existing connection be used and no additional connections be provided;

C4 DEVELOPMENT CHARGES

- (b) The approval does not exonerate the applicant from obtaining the necessary approval(s) from any other applicable statutory authority;
- (c) The applicant/objectors be notified of the outcome and their right to appeal in terms of Chapter VII, Section 89 of the By-law;
- F. The application for a consent use on Erf 278, Koringberg be refused, in terms of Section 70 of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), in order to accommodate a bottle store;

F1 TOWN PLANNING AND BUILDING CONTROL

- (a) The SDF only allows for limited business uses along activity corridors, thus the proposed land use is contradictory to the spatial planning for the area;
- (b) The combination of the bottle store with the place of assembly will constitute a land use that is not consistent with the character of the residential neighbourhood;
- (c) In addition to the residential character of the neighbourhood, the application property is located within 150 m of places of education and social amenities and as such poses a threat to the social and moral wellbeing of the children in the community. The location of the proposed bottle store is in contradiction to the Western Cape Strategic Plan Framework (2019 2024).
- G. The reasons for supporting the application are as follows:
 - (a) The proposed flats are consistent with the SDF that promotes flats along activity corridors/streets:
 - (b) The flats are also consistent with local, provincial and national legislation and policy promoting densification inside the urban edge;
 - (c) The shops and place of assembly are consistent with the spatial proposals of the SDF that supports limited business development along activity corridors/streets in area A:
 - (d) The place of assembly will make a social facility available to a lower income group that does not necessarily have access to the existing facilities in Koringberg;
 - (e) Mitigating measures have been recommended in order to limit the possible disturbances that may be caused by the place of assembly;
 - (f) The buildings on the property are existing and no additional construction is proposed. The application for departure from building lines is to formalise the encroachment of the existing building on the new, more restrictive building lines of Business Zone 2 and not because of unauthorised building work;
 - (g) The non-provision of on-site parking is considered acceptable, as it is foreseen that some of the bays may be utilised at alternate times, some guests or residents may not have cars or make use of public transport and the non-provision may be mitigated through a financial contribution to the municipality that may in turn be utilised to upgrade the taxi terminal, for instance;
 - (h) The development proposal will not negatively impact on the character of the surrounding neighbourhood or the larger Koringberg, as the nature and scale of the development is limited and appropriate in the context;
 - (i) The owner/developer runs the risk of losing the land use approval, should any unauthorised land use continue;
 - (j) The concerns of the neighbouring and affected property owners are sufficiently addressed in the conditions of approval;
- H. The reasons for refusal of the application are as follows:
 - (a) The SDF only allows for limited business uses along activity corridors, thus the proposed land use is contradictory to the spatial planning for the area;
 - (b) The combination of the bottle store with the place of assembly will constitute a land use that is not consistent with the character of the residential neighbourhood;

(c) In addition to the residential character of the neighbourhood, the application property is located within 150 m of places of education and social amenities and as such poses a threat to the social and moral wellbeing of the children in the community. The location of the proposed bottle store is in contradiction to the Western Cape Strategic Plan Framework (2019 – 2024).

6.2 APPLICATION FOR REZONING ON ERF 515, YZERFONTEIN (15/3/3-14) (WARD 5)

The author, Mr H Olivier, mentioned that the conveyancer's certificate was requested in order to obtain the opinion from the Registrar regarding the rezoning of Erf 515, Yzerfontein.

Mr Olivier confirmed that the rezoning of Erf 515, Yzerfontein is restricted by the following conditions imposed by the Title Deed, namely:

"C.3 No building on this erf shall be used or converted to use for any purpose other than permitted in terms of these conditions."

"C.6.(a) This erf shall be used solely for the purpose of erecting thereon one dwelling or other buildings for such purpose as the Administrator may, from time to time after reference to the Township Board and the local authority, approve, provided that if the erf is included within the area of a Town Planning Scheme, the local authority may permit such other building as are permitted by the scheme subject to the conditions and restrictions stipulated by the scheme."

The Municipal Planning Tribunal concurred that the application be referred back for the amendment thereof regarding the removal of restrictive conditions in order to consider the rezoning of Erf 515, Yzerfontein.

RESOLUTION

That the application be referred back to request the applicant to amend the application to include the application for removal of restrictive conditions and to allow for public participation accordingly.

6.3 PROPOSED DEPARTURE OF DEVELOPMENT PARAMETERS ON ERF 1631, YZERFONTEIN (15/3/4-14) (WARD 5)

[The Director: Corporate Services, Ms M S Terblanche joined the meeting.]

Mr A J Burger, as author, elaborated on the reasons for the refusal to depart from the development parameters on Erf 1631, Yzerfontein. Mr Burger confirmed that there are no merits to approve the departures.

RESOLUTION

A. The application for the departure of development parameters on Erf 1631, Yzerfontein, in order to depart from the 1 m maximum height from which the groundfloor of a building may be raised above the natural ground level to 1,892 m and the 10,5 m height restriction of the highest point of the roof in the case of pitched roofs to 10,867 m, be refused in terms of section 70 of the Swartland Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020):

B. **GENERAL**

- (a) The applicant/objectors be informed of the right to appeal against the decision of the Municipal Planning Tribunal, within 21 days of this notice, in terms of section 89(2) of the By-Law;
- C. The application be refused for the following reasons:
 - (a) Erf 1631 is vacant;
 - (b) Erf 1631 has a marginal slope from the street to the rear of the property with no other physical restrictions;
 - (c) There are no architectural design guidelines applicable to Erf 1631 which gives optimal design freedom within the zoning parameters and National Building Regulations;

6.3/...

- (d) Erf 1631 is situated on the sea front giving unobstructed views towards the beach and ocean:
- (e) The impact on views from affected properties are deemed a right and need to be protected as the owner/developer intends to develop the property outside the permitted land use rights.

6.4 PROPOSED CONSENT USE ON ERF 1821, YZERFONTEIN (15/3/10-14) (WARD 5)

An application for a consent use on Erf 1821, Yzerfontein was received in order to accommodate a second dwelling on the property.

Mr Olivier confirmed that Erf 1821, Yzerfontein is currently zoned Residential Zone 1 and that a second dwelling is permitted as a consent use under the Residential Zone 1 zoning.

RESOLUTION

A. The application for consent use on Erf 1821, Yzerfontein be approved, in terms of Section 70 of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020), subject to the conditions:

A1 TOWN PLANNING AND BUILDING CONTROL

- (a) The consent use authorises a second dwelling, as presented in the application;
- (b) The second dwelling adheres to the applicable development parameters;
- (c) Building plans be submitted to the Senior Manager: Built Environment for consideration and approval;

A2 WATER

(a) A single water connection be provided and no additional connections be provided;

A3 SEWERAGE

(a) The property be provided with a conservancy tank of minimum 8 000 litre capacity and that the tank be accessible to the municipal service truck via the street;

A4 DEVELOPMENT CHARGES

- (a) The owner/developer be responsible for the development charge of R5 445,25 towards the supply of regional bulk water, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA: 9/249-176-9210);
- (b) The owner/develop be responsible for the development charge of R4 502,25 towards bulk water reticulation, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA 9/249-174-9210);
- (c) The owner/developer be responsible for the development charge of R8 280,00 towards waste water treatment, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA 9/240-183-9210);
- (d) The owner/develop be responsible for the development charge of R5 612,00 towards sewerage, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA 9/240-184-9210);
- (e) The owner/developer be responsible for the development charge of R11 500,00 towards streets, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter. (mSCOA 9/249-188-9210);
- (f) The owner/developer be responsible for the development charge of R3 192,40 towards storm water, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA 9/248-144-9210);
- (g) The owner/developer be responsible for the development charge or R10 419,00 towards electricity, at building plan stage. The amount is due to Swartland Municipality, valid for the financial year of 2021/2022 and may be revised thereafter (mSCOA 9/253-164-9210);

(h) The Council resolution of May 2021 makes provision for a 40% discount on development charges to Swartland Municipality. The discount is valid for the financial year 2021/2022 and may be revised thereafter. The discount is not applicable to A4(a);

B. **GENERAL**

- (a) The approval is, in terms of section 76(2)(w) of the By-Law, valid for a period of 5 years. All conditions of approval be complied with before an occupancy certificate be issued and failing to do so may result in administrative action;
- (b) The approval does not exonerate the applicant from obtaining any necessary approval from any other applicable statutory authority;
- (c) The applicant/objectors be notified of the outcome and their right to appeal in terms of Chapter VII, Section 89 of the By-law;
- C. The application be supported for the following reasons:
 - (a) The proposed second dwelling is a residential use and is therefore consistent with the proposals of the SDF;
 - (b) A second dwelling is accommodated as a consent use under Residential Zone 1 of the By-Law;
 - (c) The development proposal supports the optimal utilisation of the property;
 - (d) The second dwelling may support the tourism industry in Yzerfontein, as well as the local economy;
 - (e) The second dwelling provides in a need for a larger variety of housing opportunities to the wider population;
 - (f) The development proposal will not negatively impact on the character of the surrounding neighbourhood or the larger Yzerfontein.

6.5 PROPOSED CONSENT USE AND DEPARTURE ON ERF 11180, MALMESBURY (15/3/10-8; 15/3/4-8) (WARD 8)

Mr Burger, as author, confirmed that the application entails the consent use on Erf 11180 to establish a double dwelling and the departure to depart from the required 4 on-site parking bays to 0 on-site parking bays.

Mr Burger stated that historically Erf 11180, Malmesbury did not provide on-site parking and a total of 4 on-site parking bays for the double dwelling house are required according to Residential zone 1 zoning parameters. However, credit can only be given for 2 on-site parking bays.

A discussion followed on the levying of a tariff for the continued illegal land use and it is established that Section 96(3) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020) authorises the institution of a fine for every day the illegal land use continues.

RESOLUTION

 - (b) Credit be given for the non-provision of 2 on-site parking bays and a financial contribution be made for the non-provision of the remaining 2 on-site parking bays calculated at R900/m² x 25 m² = R22 500,00

C. GENERAL

- (a) The approval is, in terms of section 76(2)(w) of the By-Law, valid for 5 years. All conditions of approval be complied with within a period of 2 months, by 16 May 2022, after which the 5 year period will no longer be applicable;
- (b) The approval does not exonerate the applicant from obtaining any necessary approval(s) from any other applicable statutory authority;
- (c) The applicant/objectors be notified of the outcome and their right to appeal in terms of Chapter VII, Section 89 of the By-law;
- D. The application be supported for the following reasons:
 - (a) The application is in compliance with the planning principles of LUPA and SPLUMA;
 - (b) The application is consistent with local, regional and provincial spatial planning policy regarding densification;
 - (c) The development proposal complies with all applicable zoning parameters of the Residential zone 1 zoning, except for on-site parking;
 - (d) The proposed double dwelling will complement and not have a negative impact on the character of the surrounding residential area;
 - (e) The development proposal supports the optimal utilisation of the property;
 - (f) The proposed land use is considered as a desirable activity within a residential neighbourhood, as it will accommodate residential activities compatible with that of the existing area;

6.5/D...

- (g) The double dwelling will provide in a need for a larger variety of housing opportunities to the wider population;
- (h) Sufficient services capacity exists to accommodate the proposed double dwelling;
- The number of people or number of families which may reside in a dwelling house is not a decision making criteria for a consent use for second dwelling or double dwelling;
- (j) The historical situation regarding the provision of no on-site parking on Erf 11180 will continue to exist:
- (k) Section 96(3) of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020) authorises the institution of a fine for every day the illegal land use continues. Municipal tariffs make provision for a tariff to be levied for a continued unauthorised land use. The reluctance of the owner to rectify the illegal land use and unauthorised building work cannot be condoned.

6.6 APPLICATION FOR A DEPARTURE ON ERF 742, MALMESBURY (15/4/2-8) (WARD 10)

Mr Olivier, as author, discussed the application for a departure on Erf 742, Malmesbury in order to accommodate the existing wooden structure.

The property is currently zoned Residential Zone 1 and the applicable building lines are 4 m street, 1,5 m side and 2 m rear. The structure, as per proposed building plan, is situated only 550 mm from the rear property boundary.

Mr Olivier explained the reasons for the refusal of the application as stated in the report.

RESOLUTION

A. The application for a departure from development parameters on Erf 742, Malmesbury be refused in terms of Section 70 of the Swartland Municipality: Municipal Land Use Planning By-Law (PG 8226 of 25 March 2020);

A1 TOWN PLANNING AND BUILDING CONTROL

- (a) The portion of the structure encroaching the building lines be demolished before 9 May 2022;
- (b) That amending building plans be submitted to the Senior Manager: Built Environment for consideration and approval;
- B. The applicant and objector be informed of their right to appeal against this decision of the Municipal Planning Tribunal, in terms of section 89(2) of the By-Law;
- C. The application be refused for the following reasons:
 - (a) Building lines are control measures that not only accommodate services but also preserve the nature and character of the area. The sheer extent of the structure is such that the applicants need can be accommodated without encrouching the building line;
 - (b) It is clear from Division: Building Control that the structure needs to undergo significant alterations for it to comply with the National Building regulations.



EXECUTIVE SUMMARY

1. INTRODUCTION

The Traffic and Law Enforcement Service of Swartland Municipality executed their normal mandate and assisted SAPS to enforce the Lockdown Regulations during the month of **March 2022** to enhance service delivery.

2. LAW ENFORCEMENT

This division ensure bylaw compliance and education to all communities within the Swartland municipal area. The Law Enforcement Division attended to all by-law related issues as well as the Lockdown Regulations.

2.1. MONITORING OF INFORMAL SETTLEMENTS

The Traffic and Law Enforcement Division is mandated through the IDP to monitor all informal settlements within the Swartland municipal area and to prevent and manage land invasion. The key performance indicator is to report on any developments thereof to the Portfolio committee. Monitoring of Silvertown informal settlement, Chatsworth, Riverlands and Sibanye (Moorreesburg) is ongoing.

2.2. DOG UNIT (K9-UNIT)

The Dog-Unit work 8-hour shifts. There shifts are adaptable to cover enforcement over weekends.

The Unit can report the following for the month:

- Total searches done vehicles and houses 347
- 14 X Crime Prevention operations
- 6 X K78 Roadblock assistance
- (14) Fourteen searches conducted in the form of VCPs, K78-Roadblocks and search and seizure in collaboration with SAPS executed for the month of **March 2022**. Details are available in the report.
- (0) Zero cross boundary assistance to SAPS or municipalities within West Coast for the month.

The K9 unit had a total of 32 arrests for the month of March 2022.

3. REGISTRATION AND LICENSING

3.1. DRIVING AND LEARNERS LICENSES

Driving and learners' licenses create job opportunities and allow people to better their standard of living. The following can be report for Malmesbury and Moorreesburg Driving License Testing Centres (DLTC's):

Malmesbury:

Driving licence Pass rate for the month = 44%

Learners Licence Pass rate for the month = 53%

Applicants absent for the month 85= (Driving licenses 65= Learners 20)

Moorreesburg:

Driving licence Pass rate for the month = 38%

Learners Licence Pass rate for the month = 80%

Applicants absent 26= (Driving licenses 19 = Learners 7)

Learners Licence Pass rate for the month = 45%

Applicants absent = 1

3.2 VEHICLE TESTING STATIONS (VTS)

Malmesbury VTS had a total of 113 roadworthy tests and Moorreesburg VTS done 52 roadworthy tests for the month of March 2022.

4. TRAFFIC DIVISION

The traffic operational division can report the following for the month of March 2022.

- Road blocks (K78) = 1
- Vehicle Check Points (VCP's) = 42
- Foot Patrols = 33

667 offences were recorded (This includes the cases recorded by Law Enforcement and Traffic).

4.1 WARRANT SECTION

The warrant and speed section execute warrants on a daily basis. Special efforts to enhance the executing of warrants and to increase the payment rate are of the essence. Hundred & thirty (130) warrants were finalized to the value of R74 150.00

4.2. SPEEDING ENFORCEMENT

The 3 mobile cameras recorded **4271** cases and the fixed sites recorded **292** speeding cases. **1430** cases were recorded by the ASOD on the R27.

The total **speeding offences** for the month of **March 2022** were **5993.** We enhanced our speeding enforcement efforts to reduce accidents.

4.3. AUTOMATED NUMBER PLATE RECOGNITION OPERATIONS (ANPR OPERATIONS)

Four (4) ANPR operations were executed for the month of March 2022 and R111 350.00 of outstanding traffic fines collected via this effort.

4.4 SAFETY AWARENESS

SEVEN (7) Educational programmes executed for the month of March 2022.

5. HIGHLIGHTS

- Working with SAPS and other stakeholders brought successes and good integrated collaboration with crime prevention initiatives.
- We are part of the Executive Mayors visits to our towns.
- Our K9 unit through hard work find successes in various operations and the confiscation of drugs and illegal alcohol is still ongoing. Removing these drugs from our streets and communities are paramount.
- Starting the process for the recruitment of members for the reaction unit

- Planning for the Easter weekend is progressing.
- Monitoring council's land at De Hoop and Illinge Lethu for possible invasion.
- Strengthen efforts to address the illegal dumping in the Swartland Area
- Our department is actively involved in the Covid-19 JOC meetings.
- Monitoring erecting of illegal structures in Riverlands, Saamstaan and Illinge Lethu and effect the breakdown of these illegal structures.
- Successful operations with SAPS and the Western Cape Liquor Authority (WCLA) over the Swartland Municipal Area is ongoing.




